

In 2017, CATCH Global Foundation continued this program's focus on low-income urban communities. Major projects included Brownsville schools in South Texas (funded by a grant from Valley Baptist Legacy Foundation), Jefferson Parish schools in Louisiana (funded by a grant from Humana Foundation), and ongoing work in select counties in California and New York (funded by SNAP-Ed). We also added the CATCH K-8 health education curriculum to our CATCH.org portal to increase accessibility to teachers. Finally, CATCH Global Foundation provided support, evaluation assistance and technical assistance to schools around the country who were expanding or sustaining the CATCH Coordinated School Health program. In total CATCH's programs now reach approximately 2.5 million school-age

4b (Code: ) (Expenses \$ 169,838. including grants of \$ ) (Revenue \$ 476,453. ) Out-of-School Physical Activity & Nutrition Education. In 2017, CATCH Global Foundation brought the CATCH pre-school and after-school programs to youth around the country including new projects in Comal ISD TX, various communities in California, and several areas of Colorado (funded by a grant from Buell Foundation). CATCH Global Foundation also provided support, evaluation assistance and technical assistance to out-of-school sites who were expanding or sustaining the CATCH Out-of-School programs.

4c (Code: ) (Expenses \$ 133,476. including grants of \$ ) (Revenue \$ 77,054. ) Sun Safety. In 2017, CATCH expanded its sun safety education to children ages 3-7 using Ray and the Sunbeatables, developed by The University of Texas MD Anderson Cancer Center, reaching 1,350 new sites serving approximately 124,000 children during the year. We also created free online access to this program through sunbeatables.org.
